# GEORGIA SUPREME CRICKET LEAGUE (GASCL)

## FULL 30 OVERS PLAYING CONDITIONS – 2026

These Playing Conditions are issued under the authority of the GASCL Constitution and By-Laws. They incorporate applicable ICC Playing Conditions while remaining specific to GASCL competitions. In the event of conflict, GASCL governance documents prevail.

## **1. DEFINITIONS & AUTHORITY**

1.1 These Playing Conditions apply to all GASCL 30-Over competitions.

1.2 ICC Limited-Overs Playing Conditions apply except where varied herein.

## **2. MATCH FORMAT & TIMING**

2.1 Each innings shall be limited to thirty (30) overs.

2.2 Interval between innings shall not exceed fifteen (15) minutes.

## **3. POWERPLAY & FIELDING RESTRICTIONS**

3.1 Powerplay overs shall be the first ten (10) overs.

3.2 During Powerplay, no more than two (2) fielders may be outside the circle.

3.3 Thereafter, no more than five (5) fielders may be outside the circle.

## **4. BOWLING RESTRICTIONS**

4.1 No bowler may bowl more than six (6) overs.

4.2 Bowling quotas shall be recalculated proportionally if overs are reduced.

## **5. NO SUPER OVERS**

5.1 There shall be no Super Overs under any circumstance.

5.2 Matches tied on runs shall remain tied.

## **6. NO BALLS & WIDES**

6.1 ICC front-foot no-ball laws apply.

6.2 Wides shall be judged strictly at the discretion of the umpire.

## **7. INTERRUPTED MATCHES & DLS**

7.1 A minimum of ten (10) overs per side is required for a result.

7.2 DLS via the CricClubs DLS App is mandatory.

7.3 Tied DLS results remain ties.

## **8. BALLS, BOUNDARIES & EQUIPMENT**

8.1 GASCL-approved match balls shall be used.

8.2 Boundary markers must be clearly visible.

## **9. SUBSTITUTES, INJURIES & CONCUSSION**

9.1 Substitutes may field only.

9.2 Injury replacements are not permitted except as allowed by law.

## **10. OVERRATES & DELAYED PLAY**

10.1 Teams are expected to complete overs within allotted time.

10.2 Repeated delays may attract disciplinary action.

## **11. RESULTS & POINTS**

11.1 Win: 10 points; Loss: 0 points.

11.2 Tie: 5 points each.

11.3 Abandoned/No Result: 5 points each.

## **12. DISCIPLINE & FINAL AUTHORITY**

12.1 Umpires control the match.

12.2 GASCL MEC is final authority on all disputes.

## RATIFICATION & ADOPTION
